#### What has made Words to Deeds unique over the last 20 years?

The goal of Words to Deeds (W2D) is to convene thought leaders from California's state and county behavioral health and public safety departments to discuss implementation challenges and highlight solutions that prevent people with behavioral health (i.e., mental health and/or substance use disorder) needs from becoming involved with the criminal justice system.

By establishing peer-to-peer dialogue, we strive to establish the platform for increased relationship-building, learning, and continuous improvement across systems and jurisdictions that can help practitioners sustain more outcomes-focused and responsive services.

#### What happens after the event?

We will submit a report to the state to enhance the future delivery of forensic behavioral health care and related services. The report will highlight recommendations and challenges prioritized during the conference by speakers and attendees.

Also proposed are continued workgroups/communities of practice comprised of interested attendees and others who may wish to join post-meeting. These groups may meet during the next 12 months, maybe quarterly (or as the group decides), to continue exploring the validity/usefulness of the convening's insights and action items and report back to W2D 2025 on their discoveries.
