Reentry Services That Are Available

Level of care based on assessed needs and availability

- Detoxification
- Female Offender Treatment Employment Program (FOTEP)
- Licensed Residential Treatment Services
- Reentry and Recovery Housing
- Substance Use Disorder Outpatient Treatment Services
- Other Outpatient Services
- Medically Assisted Treatment (MAT)







Licensed Residential Treatment Services

Length of treatment based on assessed need; rehabilitation Services Offered:

- Counseling Individual/Family/Group
- Substance Use Disorder Assessment/Treatment Planning
- Services focused at developing cognitive and behavioral skills for management of stress, anger and violence related to criminality
- Preventive and primary health care services and/or referrals
- Health Education Services referrals
- Employment and Educational Services and/or referrals
- Life Skills program and/or referrals
- Community referrals
- Social integration and recreational activities



Reentry & Recovery Housing

- Housing
- Attendance in Outpatient Treatment Services or Other Outpatient Services is required
- Food Services
- Basic Hygiene
- Laundry Services

Non-residential treatment services

Rehabilitation Services offered as determined in the Treatment Plan:

- Counseling Individual/Family/Group
- Substance Use Disorder Assessment/Treatment Planning

- Employment and Educational services and/or referrals
